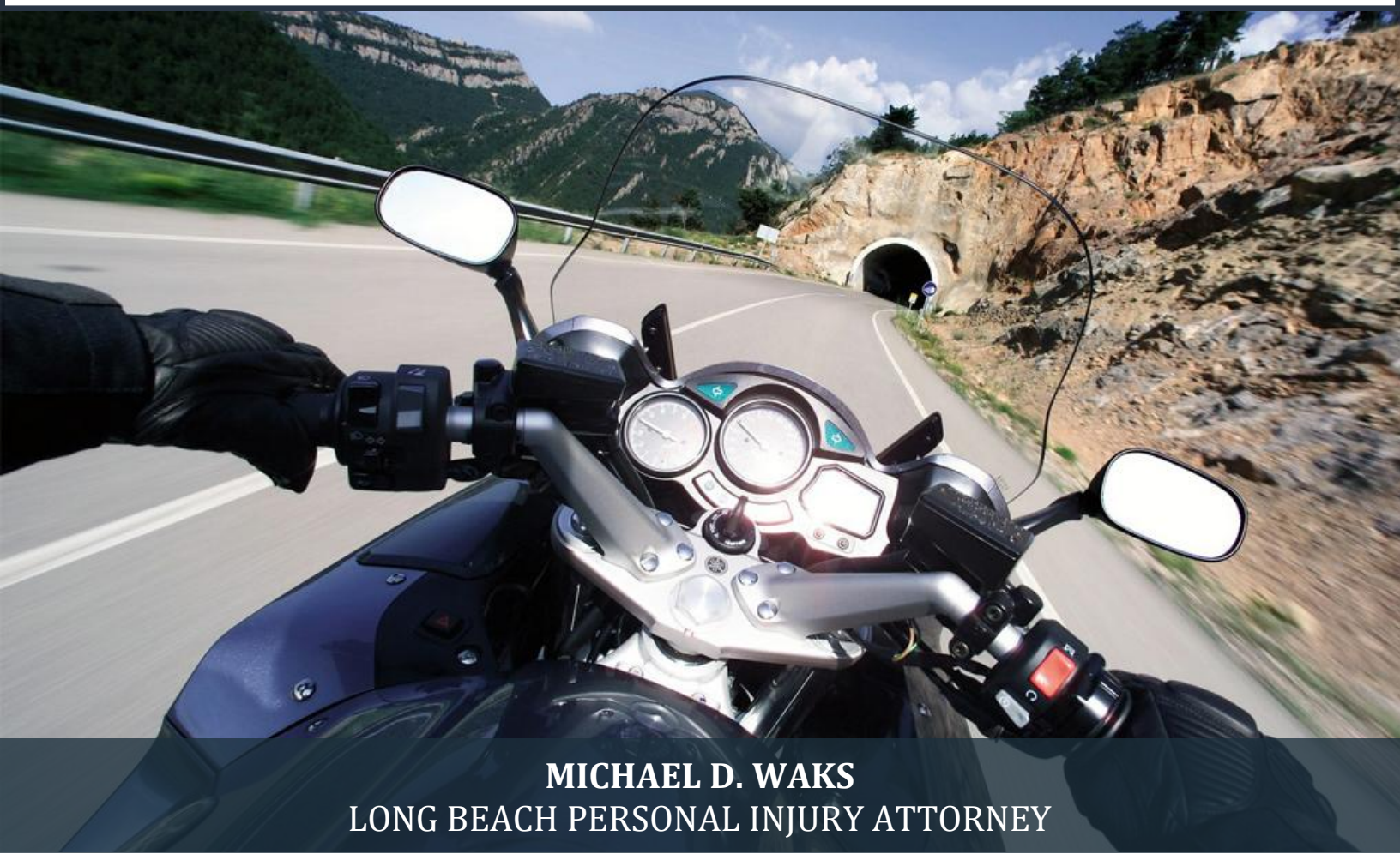

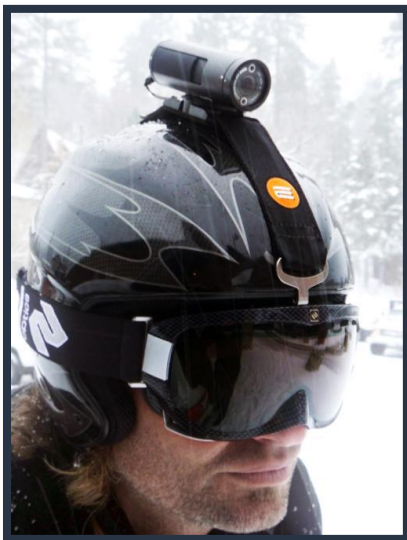

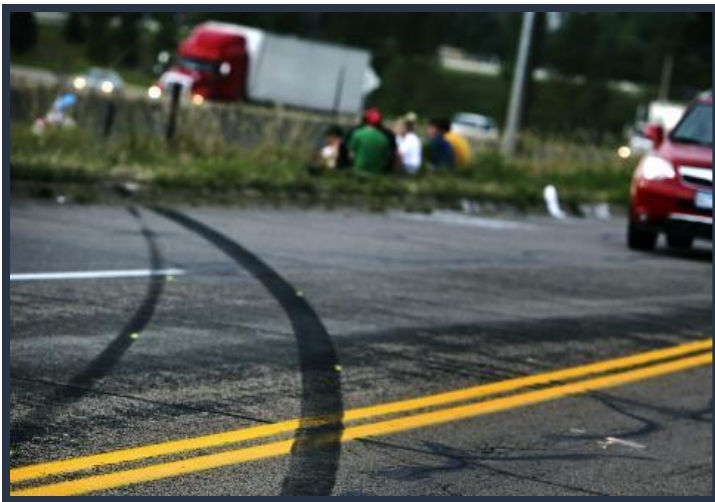
## WHAT IS A GO PRO CAMERA?



A Go Pro camera is a small camera that mounts to the rider's helmet to capture everything from the rider's point of view. Motorcyclists are using the cameras to assess and improve their riding skills and capture their ride on film to preserve memories. Go Pro cameras are a popular model of helmet cameras because they are affordable, easy to use, and come with excellent tech support and a variety of apps and add-ons. Go Pro takes high-quality videos and high-resolution images. In addition to providing wonderful memories of spectacular rides, Go Pro cameras can also provide invaluable evidence in the event of a motorcycle accident.

## USING HELMET CAMERAS AS EVIDENCE IN A MOTORCYCLE ACCIDENT CASE

Liability is often a problem in motorcycle accident cases because motorcyclists must fight the common stereotype of motorcyclists being dangerous and reckless. This stereotype is completely unfounded and unfair; however, many people believe it nonetheless. When a motorcyclist is involved in an accident, most people assume that the accident was caused by the motorcyclist driving recklessly or speeding. If there are no other witnesses, it could come down to a “he said, she said” situation. In those types of cases, a preconceived bias toward the motorcyclist could prevent the rider from collecting the damages he or she deserves from the driver who actually caused the accident.



In traditional cases, we use evidence found at the scene of the accident (i.e. skid marks, vehicle debris, etc.), to recreate the accident to help establish liability. Each driver typically has a different version of the accident; therefore, we try to find witness testimony to support

our client’s version of how the accident occurred. If we can find a video recording of the accident, we have a powerful piece of evidence that is almost impossible to refute. Finding a video recording from a traffic light camera, retail security camera or witness video is very unlikely and rare. Even in the cases where we may have a



video from one of these sources, the angle or quality may not be sufficient to establish liability.



On the other hand, a rider who has a Go Pro camera or other helmet or handlebar mounted camera has the ability to capture the entire motorcycle accident from the rider's point of view. Using a helmet or vehicle mounted camera is an excellent way to document liability to prove to an insurance adjuster or a jury that the rider was not at fault in the accident. It is difficult for a defense attorney to overcome video evidence of the accident in real time. For example, a defendant who is claiming that the motorcyclist caused the accident would have a very difficult time proving that allegation if you have video from a helmet camera that clearly shows the other driving turning left in front of you, or changing lanes directly in front of you.

Juries typically find visual images and video very convincing. When liability is in question, having a video to document the events that occurred immediately prior to

the accident may be vital to proving your case. It could mean the difference between receiving zero dollars for your injuries and hundreds of thousands of dollars for your injuries.

Whether it is someone turning in front of you, backing out of the driveway in front of you, or opening a car door in your path, you probably have many close calls each time that you ride. Having a camera to document those close calls may be exactly what you need to prove your allegations of liability in the event of a motorcycle accident. Helmet cameras are easy to install, affordable and give you peace of mind when riding your motorcycle.

Sadly, motorcycle riders have a high risk of being involved in a motorcycle accident involving severe injuries. Having a Go Pro camera is an investment in your future protection in the event that liability becomes an issue in your personal injury case. In addition to giving you a great way to preserve your rides, you are protecting yourself in the event of a serious motorcycle accident.
